00:42:24 Rachel Rebello: Tagging appropriate headers in a document allows folks using screen readers to efficiently navigate a document. Think of it like an invisible table of contents.

00:43:45 Rachel Rebello: Without tagging headers, folks relying on screen readers will need to navigate the document word by word to find what they're looking for.

00:45:53 Rachel Rebello: Library Liaisons can also help find accessible versions of scans and documents in databases. They actually encourage faculty to link directly to database materials (whenever possible) rather than adding the file to myCourses.

00:48:13 Rachel Rebello: It is far more difficult to remediate a document in Adobe for accessibility than in any other software application. (It's not a linear process in Adobe at all.)
